FROM THE CEO: HOPE HAVEN'S REDEMPTION CENTER

As many of you are aware, Hope Haven has had a can/bottle redemption center for many years. Over the past few years, several agencies like Hope Haven, quit providing this much needed service due to the inability to cover the cost. Hope Haven has been able to maintain and continue to provide this service with the hope that eventually funding would come through to support the losses experienced.

We finally prevailed thanks to advocacy efforts by many of you and legislators. Legislation was passed this year that increases the handling fee to redemption centers from one cent to three cents in January 2023. The passing of this bill will help our redemption center a great deal.

Remember, to redeem your cans and bottles please see us at 1819 Douglas Ave, Burlington, Iowa. We also accept donations! We hugely appreciate your business and the communities support in our efforts to maintain this community service.

TRAINING OUR DSP'S



We are grateful to have certified staff to provide Mandt Crisis De-escalation training to our Direct Services Professionals. Here they are providing training to the Employment Services staff.

INDIVIDUAL PLACEMENT SUPPORTS (IPS)



In January of 2022, Hope Haven Employment Services began providing Individual Placement Supports (IPS) to individuals with severe mental health diagnoses, also referred to as “Brain Health.” IPS is a rapid job search program that also incorporate frequent contact with an individual’s mental health team and other supports. During this last Quarter, 6 individuals became employed in their communities and are working independently! Maria is one of these individuals.

Maria joined Hope Haven’s Employment Program in 1992, and got her first job in 1993 working at Walmart for \$6.91 per hour. Maria’s employment journey has been one of many ups and downs, as she struggled with her brain health. She participated in many of Hope Haven’s employment training programs and small group employment settings, and had some jobs in the community as well with some success. Maria started receiving Individual Placement Supports in February, and was hired in April at “I” Care Child Care as a Custodian. Maria has been working there independently for 3 months and her supervisor and co-workers are very happy to have her there! When asked how she feels about her employment journey, Maria

said she has had a lot of ups and down with her employment because of her mental health. She said she feels like she has come a long way and is grateful to have the support of Hope Haven Employment Services who has helped her along the way!
